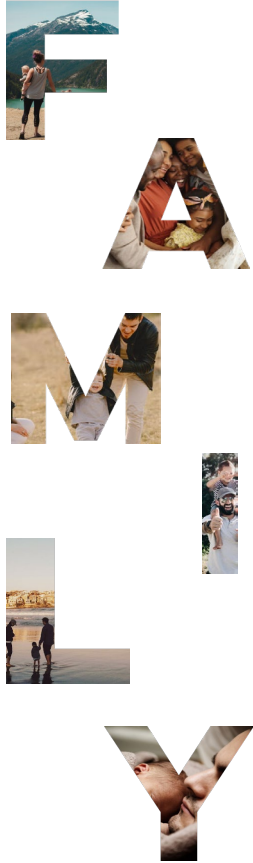

Improving outcomes for infants and families affected by perinatal substance use



Goals

- To keep the **parent-baby dyad intact** when a safe thriving environment is possible
- To **support the recovery** of pregnant and parenting individuals and their families
- To **implement County-wide policies and protocols** to support families across the care continuum

Implementation Strategies

- Increase care coordination across prenatal care providers, OC birthing hospitals, SUD providers, and others
- Establish trust by reducing stigma, discrimination and implicit bias
- Increase access to care by creating a centralized repository of resources
- Improve data collection to make informed decisions

Over 65+ Participating Organizations

The collaborative currently includes over 200 representatives from 65+ organizations (and growing), as well as persons with lived experience and individual providers. The Task Force and workgroups are led by:

- ✓ Notification Portal utilization: 53 entries

Workforce Training and Support

- ✓ Identification and prioritization of target audiences
- ✓ FWP presentation templates
- ✓ Outreach and training to 1,170+ community providers and organizations (59 sessions)

Data Collection and Exchange

- ✓ Data dashboards support data-driven informed decisions



Current Priorities for 2025 - 2026

- Partnering with families and people with lived expertise
- Expansion of trained providers prepared to support families with the FWP
- Implementation of the FWP by additional OC birthing hospitals
- Collection of meaningful data to drive Task Force priorities
